## S-7: At least two members of a declared team must

participate in a ride for the points earned to count toward year end awards for that team. At least two members of your team must ride for your team to receive team points. For example: If the "Oregon Gal's" are a declared team with four riders listed as team members, as long as two of the team members ride together in a ride, they will accumulate team points. If Claire Sands (Oregon Gal's) were to ride with Kerry Noble (Long Haulers) neither team would accumulate team points. If Kerry Noble (Long Haulers) were to join Jessica Mala (Oregon Gal's) and Claire Sands (Oregon Gal's), the Oregon Gal's would accumulate team points and Kerry Noble would check Group on her entry form while the Claire Sands and Jessica Mala would check declared team.

## **EXAMPLE - We have the following declared teams:**

- WA-1 Donna Amos, Noella Novarra & Rose Montgomery
- WA-2 Pat & Tami Merriman
- WA-3 Mary Gazaway, Leona Merryman & Larry Hewitt Mary Gazaway as an Individual

If Mary Gazaway rides alone she will check **Individual**.

If Mary Gazaway rides with Leona Merryman, they will both check **Declared Team** and write WA-3 and the team name on their entry forms.

If Mary Gazaway rides the second day with Pat & Tami Merriman, Mary would check **Group** and Pat and Tami would check **Declared Team** and list WA-2 and their declared team name. Because Mary is not a team member, she would not accrue team points for this team, nor would she accrue points as an individual. In all cases rider points are credited towards lifetime totals.
